  - a. Scott stated that FERC granted PJM the extension to submit its order no 2222 compliance filing from July 19, 2021 to February 1, 2022.
  - b. Scott also stated that PJM plans on scheduling EDC coordination workshops through the rest of the 2021 year.

### Order 2222 – Straw Proposal Feedback (10:15 – 11:45)

4. Stakeholders engaged in a feedback session and discussion around the first three sections of the PJM Staff straw proposal presented at the March 31<sup>st</sup> DIRS meeting - Jurisdiction and Interconnection, Operations, and Markets.
  - a. Christopher Wehr, FE, discussed several topics from PJM's straw proposal such as Interconnection, Jurisdiction, opt-in small utility, weighting factors and locational requirements.
  - b. Wanda Reder, PPL, discussed FERC order 2222 filing extension, path forward, EDC objectives and proposed approach, EDC coordination timeline and EDC preliminary reactions.
  - c. Multiple Stakeholders also weighed in on PJM's straw proposal topics for an interactive discussion.
