- Update on NERC SOCCED changes

The DTS was advised that NERC will be updating SOCCED during Q4 of 2017. During the update period, there will be a 3 week data freeze where individual and provider accounts will be inaccessible. While firm implementation dates have not yet been provided by NERC, they are advising operators and providers to back-up their data prior to this update.
