<p><b>Drill Summary</b></p>	<p><b><u>General Information:</u></b></p> <p>PJM will conduct a two day East Restoration Drill, commencing on Wednesday, October 28<sup>th</sup>, 2020 at 0800 hours EPT. Drill activities will be suspended at 1400 hours EPT on October 28<sup>th</sup> and resume at 0800 hours EPT Thursday, October 29<sup>th</sup>. The drill will finish at 1300 hours EPT on October 29<sup>th</sup>.</p> <p>The East Restoration Drill provides an opportunity for all applicable entities to comply with the various NERC Standards and requirements</p> <p>PJM will have experienced a large system disturbance and the vast majority of the footprint will be blacked out. This year’s drill will assume all facilities are available unless requested by the TOs to be unavailable as part of their injects.</p> <p>PJM will utilize its OTS during the drill. A full complement of PJM system operators will participate in the training exercise. Detailed documentation of the restoration procedures, as well as black start generating units performing intended functions, will be logged and archived.</p> <p><b><u>PJM Drill Responsibilities:</u></b></p> <ol style="list-style-type: none"> <li>1. Coordinate activities with all participating Transmission Owners. Generation Operators are required to participate if they have assets listed in the Transmission Owners Restoration Plan. PJM will collect system status information and provide restoration status updates to participating members.</li> <li>2. Be proactive in identifying opportunities to assist the TOs in the restoration process.</li> <li>3. Direct the restoration of ALL available 765 / 500kV transmission facilities that had been interrupted by the end of the drill, provided an appropriate amount of load and generation had also been restored.</li> <li>4. Facilitate all interactions and schedules with outside pools / control areas.</li> <li>5. Coordinate the restoration process with fuel-limited, unavailable generation and / or possibly damaged transmission equipment.</li> <li>6. Assume frequency control when appropriate.</li> <li>7. Calculate an ACE, and return to a centrally coordinated or normal operation when appropriate.</li> </ol> <p><b><u>TO Expectations:</u></b></p> <ol style="list-style-type: none"> <li>1. Each Transmission Owner is required to confirm with PJM that they will start the drill from a total blackout.</li> <li>2. Transmission Owners may request injects that will be used as part of the drill scenario. These must be submitted to PJM by October 9<sup>th</sup>, 2020.</li> <li>3. Correct and report any restoration plan deficiencies found during the simulated restoration exercise. If deviations to a restoration plan need to occur, please</li> </ol>

	<p>notify PJM.</p> <ol style="list-style-type: none"> <li>4. Ensure that all nuclear units have been provided with off-site sources for safe shutdown power within 4 hours. Transmission Owners are required to notify the nuclear units within their transmission zone of expected arrival of safe shutdown power.</li> <li>5. Utilize appropriate internal / external Communication Protocols.</li> <li>6. Participants will be asked to evaluate drill activities, tools and processes via coordinated debriefs and during future PJM DTS (Dispatcher Training Subcommittee) meetings.</li> </ol> <p><b><u>GO Expectations:</u></b></p> <ol style="list-style-type: none"> <li>1. Participate as needed with the TO during the restoration drill in the zone where your units are located</li> <li>2. Provide requested information to the TO regarding unit availability and/or unit start-up times.</li> <li>3. Document and send updated to PJM as requested (per Manual 36) with unit data in the requested TO zone.</li> <li>4. During this year's drill, all generation will be assumed available unless requested as unavailable as part of an inject.</li> </ol>
