Administration

Mr. Ken Schuyler opened the meeting and reviewed the Agenda.

Mr. Joseph Carl reviewed the Anti-Trust and Code of Conduct and performed the roll call.

The meeting minutes from the November 23, 2015 meeting were approved.

Education

Mr. Tom Falin provided a presentation on ICAP and CIR Determinations of Intermittent Resources. This issue is being discussed at the Planning Committee, which next meets on Thursday March 10. PJM proposes to publish new class averages based on various types of wind and solar units. The class averages apply to new resources or existing resources that have not yet accumulated three years of operating data and will be posted on pjm.com rather than in Manual 21 and would be effective in the 2017/2018 delivery year.

Mr. Jeff Bastian provided information on Capacity Performance/Aggregated Offers. Capacity Performance Resources must be capable of sustained, predictable operation that allows the resource to be available to provide energy and reserves during performance assessment hours throughout the delivery year. Base Capacity Resources must be capable of providing energy and reserves during hot weather operations. Resources which may not alone meet the requirements of Capacity Performance may combine their capabilities and offer as a single aggregated resource.

Ms. Risa Holland reviewed the upcoming Day-ahead Market timing changes that will be effective April 1, 2016.

Ms. Risa Holland provided a status update on the transition from eMKT to Markets Gateway. A quick start guide will be available on pjm.com to assist members in performing tasks in Markets Gateway.

Mr. Ken Schuyler outlined two recent problem statements from the January 28, 2016 MRC meeting. (1) Concern about the ability of certain resources with different seasonal availabilities to participate at meaningful levels as Capacity Resources to be studied by the new Seasonal Capacity Resources Senior Task Force headed by PJM's Scott Baker. (2) Distributed Energy Resources in PJM have been on the increase and warrants PJM stakeholder consideration on the most effective and least cost solution to integrate these systems into the PJM market. This issue will be taken up by a new MRC subgroup facilitated by Dave Anders.

Mr. Ken Schuyler reviewed PJM Wind Curtailment Statistics.

Mr. Joe Mulhern provided an update on the progress for Solar Power Forecasts in PJM. Final reviews of RFP responses are underway, with expectation to notify winning vendor in 2Q 2016 with expectation for forecasts to begin by 4Q 2016.
