1. Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the February 18, 2014 MSS meeting.

2. eMTR and InSchedule Deadlines

Mr. Eric Hsia, PJM, gave an overview of the three packages that garnered the most support at last month's MSS meeting. Ms. Suzanne Coyne, PJM, reviewed examples of data submittal timelines, impacts to billing timelines, and information on billing line item and reporting impacts. Each package was reviewed in detail, with member comments focused on minimizing impacts to credit and preventing the existing billing timing from being extended.

Modifications to Package F-Phase 1 and Package F-Phase 2 were proposed as additional packages and documented as F-Phase 1A and F-Phase 2A in the matrix. The changes to Package F-Phase 1 include adding Balancing Operating Reserve deviation load reconciliation to items that are reconciled under the current timeframe and method. The changes to Package F-Phase 2 include keeping the Load Reconciliation (Settlement C) at 60 days rather than Phase 2's proposal of 90 days.

Mr. Hsia requested that the Subcommittee review the updated proposals and provide feedback to mss@pjm.com.

3. Capacity Peak Load Contribution (PLC) Charge Reconciliation

PJM reviewed the current timing related to the submittal of Capacity Peak Load Contribution (PLC) and Network Service Peak Load (NSPL) information and informed the subcommittee that there were no technical issues preventing the extension of the existing deadline. However, attention was brought to a potential conflict related to an item currently being worked on by the Credit Subcommittee. PJM will provide an update regarding the potential conflict at the April MSS meeting.



4. Miscellaneous Settlements Items

Ms. Susan Kenney, PJM, informed the stakeholders of upcoming MSRS changes supporting Emergency Load Response billing. Documentation may be found on the MSRS Reports page of PJM.com
