Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the April 21, 2016 MSS meeting.

Working Issues

1. Capacity Performance – Member Default of Non-Performance Charges

Mr. Ray Fernandez, PJM, presented an update on the settlement, billing, and credit impacts of a member default that includes Non-Performance Charges. Ray explained that Non-Performance Charges will be handled separately from the normal default process, and Bonus Performance Credits are tied directly to Non-Performance Charges. The default of Non-Performance charges reduces the Bonus Performance Credits on a pro-rata share.

2. Capacity Performance Charges and Bonus Performance Credits

Mr. Ed Rich, PJM, discussed the upcoming billing and report changes related to Capacity Performance. Details were presented for the Locational Reliability Charge Summary, RPM Auction Credits, Non-Compliance Charge Summary, and Deficiency Credit Summary reports. Details for the Non-Performance and Bonus Performance reports will be discussed in a future meeting.

3. ARR Ownership Reassignments

Mr. Michael Borradaile, PJM, provided a reminder on ARR Ownership Reassignments and the June 1 implications. In order for PJM to accurately maintain and process the ARRs for an organization, PJM Settlements encourages and requests members to submit any known modeling changes that affect ARRs, and a list of any Directed Transfer Requests (dating back to February 29, 2016), to their Client Manager and/or the PJM Settlements prior to the upcoming June 1st processing day.

Miscellaneous Settlements Items

Mr. Sean Flamm, PJM, discussed the upcoming changes to the Operating Reserve Generator Credit Details report, which will be effective June 1, 2016. Details on the report updates were communicated to the MSS distribution list on May 19, 2016.
