### 1. FERC Order 825 – Discussion on Sub-Hourly Settlements

Mr. Ray Fernandez, PJM, reviewed conforming revisions to Manual 28: Operating Agreement Accounting, to address changes based on a recent FERC Compliance Order and a technical correction for Revenue Data for Settlements calculation for generation resources. ### 2. Preliminary FTR Surplus Allocation

Mr. Ray Fernandez, PJM, discussed a member request for preliminary year-to-date PJM FTR Surplus totals.

PJM has added a “Preliminary Planning Period to date Total Positive FTR Target Credits” column to the Revenue Adequacy report published on the [Financial Transmission Rights page](#) for March and April. This value, along with the sum of year-to-date net positive Hourly FTR Target Credits and the Cumulative Planning Period Surplus, can be used to determine a member’s preliminary allocation.

## Miscellaneous Settlements Items

The Subcommittee was reminded that the MSRS crystal report functionality would be removed from any reports impacted by 5-minute settlements. This topic was initially discussed in the June 2017 MSS meeting..
