1. FERC Transmission Orders Requiring Reallocations and Refunds

Ray Fernandez, PJM, provided details on the settlement impacts associated with PJM's Fast Start pricing initiative.

2. Up-To Congestion transactions in operating reserve charges

Ray Fernandez covered the compliance filing and settlement impacts related to inclusion of Up-To Congestion Transactions (UTC) in operating reserve charge allocations. Sean Flamm, PJM, provided updates on MSRS report changes related to UTC.

3. PJM Daily Counter Party Submissions

Michael Tomin, First Energy, discussed the impact of counter party PowerMeter submissions submitted very closely to the submission deadline, and the benefits of having submissions finalized in advance of the deadline.

4. MSRS refresh project

Sean Flamm discussed the status of the MSRS refresh project.
