Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the January 15, 2021 MSS meeting.

Working Issues

1. MSRS Refresh Project

Sean Flamm, PJM, gave details around the delaying of the Production environment release of the refreshed MSRS UI, and presented the forward looking project timeline.

2. FTR MSRS Report Updates

Casey Noonan, PJM, presented proposed updates to existing MSRS reports and a potential new MSRS report related to the FTR market and planning period congestion. PJM will offer a survey to gauge the membership's interest and agreement with the proposed updates.

3. Fast Start Initiative Updates

Rebecca Stadelmeyer, PJM, gave an update on the status of PJM's Fast Start initiative, and fielded questions related to PJM's February 15th compliance filing. Discussion occurred surrounding PJM's proposed May 1st, 2021 implementation date.

Miscellaneous Settlements Items

No miscellaneous settlement items were discussed.

PJM fielded a request for settlement details on FERC order 2222. PJM will provide additional details at a future MSS meeting when available. Stakeholders can currently follow updates for order 2222 through the Markets Implementation Committee.
