Market Settlements Subcommittee Conference Call April 15, 2021 1:00 p.m. – 2:15 p.m. EST

Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the March 17, 2021 MSS meeting.

Sean Flamm, PJM, provided details on a Settlement C processed in the March 2021 invoice. There were adjustments for February 2020, March 2020, and April 2020 reconciliation data that affected the UGI area.

Working Issues

1. PJM Markets Certification Exam Survey

Don Kujawski, PJM, discussed an upcoming survey that will be distributed to members relating to the PJM Markets Certification Exam. There was discussion around the contents and intentions of the survey, and it was detailed that multiple responses from the same company would be accepted, and that all practitioners involved in PJM markets would be welcomed to respond.

2. MSRS Refresh Project

Sean Flamm, PJM, detailed the Production environment release of the refreshed MSRS UI on March 31st, 2021, and also gave a quick demo of the refreshed UI's functionality.

3. Fast Start MSRS Report updates

Sean Flamm, PJM, provided details on new and updated MSRS reports related to PJM's Fast Start Initiative.

4. Power Meter and InSchedule submission deadlines

Rebecca Stadelmeyer, PJM, and Natasha Holter, PJM, lead a discussion around Power Meter and Inschedule Submission deadlines and their impacts on market settlements. Holter detailed the need and expectation to receive timely and fully correct submissions from members. Discussion occurred around the appropriate environment for the topic, and it was suggested to raise the issue of timely submittals to the Markets Implementation Committee.
