ACTION REQUIRED FOR ALL Gas-Fired GENERATION RESOURCES IN PJM

PJM has issued a new eDART Data Request to collect additional information from gasfired units. Generation Owners with gas units should work closely with their MOC/eDART contact as soon as possible to ensure responses are provided via eDART no later than 23:59 on Friday, July 12, 2024. Below please find a copy of the notification that was sent to the affected eDART GO Contacts:

In its continuing effort to learn more about natural gas supply and deliverability constraints and how those constraints impact gas fired generators, especially during periods of high demand, PJM is requesting your assistance in completing the accompanying data request. Much of the focus is on operations experienced during both Winter Storm Elliott in December 2022 as well as the more recent Winter Storm Gerri in January 2024. PJM staff intends to utilize the information gathered to help inform operations and also in continued efforts working with stakeholders on various reliability initiatives in the gas electric coordination, resource adequacy and reserve certainty areas.

The Gas Performance Data Request will open in eDART on Friday June 7, 2024, and will be open through 23:59 on Friday, July 12, 2024. The eDART data request instructions are attached.

Failure to comply with this Data Request may result in potential referral to FERC Office of Enforcement, and is potentially actionable as a violation of the Tariff, the applicable ISA, and/or Operating Agreement section 11.3.1.

Obligation to respond is not excused even if a third party asset manager or other third party contractor is responsible for fuel procurement.

Please note that PJM will share all data request responses with its independent market monitor, Monitoring Analytics, LLC. In addition, data responses could be requested by regulators and PJM would share, with member notice only, in accordance with the PJM Operating Agreement, section 18.17.

This data request must be submitted through the eDART web forms or via eDART TXT file upload, and cannot be submitted via email.
