1. Scott Baker, chair, opened the meeting and reviewed the agenda.

6. Doug Miller, Clean Energy Buyers Institute, discussed a next generation clean attribute procurement initiative along with representatives from Microsoft, Google, and Etsy.

7. Scott Baker, PJM, presented and solicited stakeholder interests regarding the development of a framework for procuring clean resource attributes. Interests were gathered from multiple stakeholders and will be published to the CAPSTF meeting materials following the meeting. 
