Key Work Activity #3

Ms. Sharon Midgley, Exelon Business Services, LLC, presented Exelon's perspective on the lack of government policy impacts on PJM Capacity Market Performance.

Mr. Anthony Giacomoni, PJM, presented additional quantification methodology for state action impact.

Mr. Murty Bhavaraju reviewed PJM's initial thoughts regarding impacts of state actions on RPM.

PJM Capacity Repricing Proposal

Mr. Adam Keech, PJM, reviewed the recently published Capacity Market Repricing Proposal. Exelon requested that PJM provide an analysis to support the alleged market harms at an upcoming CCPPSTF meeting.

Key Work Activity #4

Mr. Anders reviewed the design components currently listed in the matrix. He also discussed next steps with the group, including an update to the meeting format for both the July and August meetings, which will move to 2 day meetings. He invited stakeholders to submit solution options and solution packages which will be reviewed at these upcoming meetings.
