Administration

1. Mr. Dave Anders opened the meeting and reviewed the agenda.
2. Ms. Cheryl Mae Velasco performed roll call, reviewed the meeting guidelines, and reviewed the draft meeting minutes. Minutes were approved and will be posted as final.

Vote/Poll Results

Mr. Anders reviewed the results of the vote and poll that were distributed between April 4, 2016 and April 8, 2016. There was an overwhelming response to discuss virtual transactions at the EMUSTF as opposed to opening a new stakeholder group. The revised charter will be brought to the May MRC for approval. The poll results indicated that members were interested in continuing uplift discussions prior to hearing back from FERC. The proposed direction of the EMUSTF will be presented at the next MRC meeting.

Education

Mr. Keyur Patel provided education on the nodes that are currently available for virtual bidding. He also presented a benchmarking slide, comparing the rules for virtual transactions at the other ISO/RTOs. A comment was made that MISO and NYISO are currently working on a UTC product. A request for education was made, requesting a current list of biddable nodes and what the criteria was for selecting them. An additional education request was made for how load is bid into the Day-Ahead market nodally versus zonally. Rules around price sensitive load, fixed demand bids, and the general behaviors of virtual bidding were also discussed.

Interest Identification

Mr. Anders led the group in an exercise to identify the interests surrounding virtual transactions. The interests were documented in a new matrix that will be titled "Phase 3 – Virtual Transactions".

Review of Matrix

Mr. Anders requested that all package proposers briefly review and present the highlights of their package for both the Phase 1 and Phase 2 matrices to the task force. Members were encouraged to submit any changes to their packages prior to the next meeting.

Next Steps

Mr. Anders outlined the next steps for the group. Before the next meeting, any changes for the Phase 1 or Phase 2 matrix should be submitted. An updated workplan will be presented at the next meeting to show anticipated dates for completion of Phase 1 and Phase 2, and the expected workplan for Phase 3.
