## **Process and Work Plan**

In light of no comments being voiced, the task force was asked if there were any objections to bringing the draft to the MRC for a first read. No objections or comments were voiced. As a result, the charter will be brought to the August MRC for a first read.

#### Education

5. Angelo Marcino, PJM, presented education on the current and pending PJM market rules for use of ORDCs and Transmission Constraint Penalty Factors in LMPs including the input assumptions for the ORDCs. The education included pricing rules during emergency actions, triggers for Performance Assessment Intervals (PAI), and the automatic use of the maximum reserve penalty factors.
