### Administration

1. Susan Kenney, facilitator, provided a welcome and announcements. Andrea Yeaton, secretary, reviewed of the Anti-trust, Code of Conduct, and Public Meetings/Media Participation.

Stakeholders approved draft minutes from the December 10, 2021 Energy Price Formation Senior Task Force (EPFSTF) meeting by acclamation.

Update on Remand

 Phil D'Antonio provided an update on the FERC Order on Remand and its impact on the resulting maximum energy prices. After the EPFSTF meeting, PJM announced plans to file an updated price capping approach in the Reserve Price Formation compliance filing due 2/22/2022. The updated approach is different than the approach discussed at the 2/16/2022 EPFSTF meeting and maintains the current level of price capping (\$3700/MWh for Energy LMPs). A slide depicting the proposed price caps was presented during the MC Webinar (link).

3. Rebecca Carroll presented results of a high-level quantitative analysis performed to estimate the effect of implementing a circuit breaker during a high load day with prolonged shortage conditions.
