Dear Acting Secretary Reese,

In its May 23, 2024 Order¹ in the above-captioned proceeding, the Federal Energy Regulatory Commission (“Commission”) directed PJM Interconnection, L.L.C. (“PJM”) “to submit a compliance filing within 30 days of the date of this order to restore the language providing that stability limited generators are not eligible for LOC payments to eTariff, so that the rate on file is reflected in eTariff.”²

Today PJM submitted in Docket No. ER24-2354-000 a “clean-up” filing designed to consolidate and update the eTariff records for Tariff, Attachment K-Appendix, section 3.2 and Operating Agreement, Schedule 1, section 3.2, to reflect language that is accepted and on file, but had not been displaying in the eTariff viewer due to overlapping versions and pending proceedings. This filing contains, among other things, the applicable sentence referenced in the May 23, 2024 Order.
