**Re: Potomac-Appalachian Transmission Highline, LLC
PJM Open Access Transmission Tariff, Attachment H-19
Projected Transmission Revenue Requirement for Rate Year 2020**

Pursuant to section IV of the Formula Rate Implementation Protocols (“Protocols”) set forth in Attachment H-19B of the PJM Open Access Transmission Tariff (“PJM OATT”),¹ Potomac-Appalachian Transmission Highline, LLC (“PATH”), on behalf of its operating companies PATH West Virginia Transmission Company, LLC and PATH Allegheny Transmission Company, LLC, is submitting a Projected Transmission Revenue Requirement for Rate Year 2020 (“2020 PTRR”) to PJM for posting.

The 2020 PTRR was developed pursuant to the PATH formula rate as set forth in Attachment H-19 of the PJM OATT. Among other things, it includes refunds, with interest calculated in accordance with section 35.19a of the Commission’s regulations, for amounts due under the Commission’s January 17, 2019 order in Docket Nos. ER09-1256, *et al.*² In its February 19, 2019 compliance filing in those dockets, PATH proposed to expedite these refunds by providing refunds within 30 days of a final Commission order accepting the compliance filing. The Commission however has not yet acted on the compliance filing. Accordingly, so that refunds to customers are not delayed, PATH has included them in the 2020 PTRR. This approach is consistent with Opinion No. 554, under which the Commission instructed PATH to calculate estimated amounts to be refunded in accordance with the PATH Formula Rate Protocols and make refunds in the next Formula Rate Annual Update.³

PATH has asked PJM to post a copy of the 2020 PTRR to the transmission service formula rates section of its internet site, located at:

A copy of the 2020 PTRR is attached. Pursuant to section IV.C of the Protocols, within two business days of this submission to PJM, PATH will provide notice on PJM’s website of the time, date and location of an open meeting among Interested Parties.
