Dear Mr. Schweizer:

On December 22, 2023, GenOn Energy Management, LLC ("GEM") submitted a deactivation notice for 4 industrial CT generation units at the Morgantown Generating Station located near Newburg, Maryland, a copy of which is attached hereto as Attachment A (the "Deactivation Notice"). By way of this notice, GEM hereby rescinds the Deactivation Notice for the following 2 unts only:

Please note that this notice does not rescind or otherwise affect the deactivation notices submitted for CT5 and CT6 at the same site also included in the Deactivation Notice, which will continue to be effective June 1, 2024. We also note that following a February 29, 2024 request from Morgantown Power, FERC issued an order on May 24, 2024 cancelling the rate schedule setting forth revenue requirements for Reactive Supply and Voltage Control from Generation or Other Sources Service under Schedule 2 of the PJM Interconnection, L.L.C. Open Access Transmission Tarriff for Morgantown Power, LLC applicable to the units included in the Deactivation Notice.
