Dear Secretary Bose:

Ohio Valley Electric Corporation ("OVEC") and PJM Interconnection, L.L.C. ("PJM" and, together with OVEC, the "Parties") hereby notify the Federal Energy Regulatory Commission ("Commission") that the effective date for the tariff records accepted in the above-captioned dockets has been further delayed. On December 16, 2017, the Parties submitted ministerial revisions to the PJM Open Access Transmission Tariff ("PJM Tariff") and associated agreements necessary to implement the integration of OVEC into the PJM region (the "Revised Tariff Sheets"). On February 13, 2018, the Commission accepted the filing, granting the requested effective date of March 1, 2018 for each of the Revised Tariff Sheets. On February 26, 2018, the Parties submitted a motion to the Commission requesting a delayed effective date for the Revised Tariff Sheets of June 1, 2018, stating that the planned date for OVEC's integration into PJM had been postponed. Since submitting the February 26th Motion, OVEC

requested and PJM agreed that additional time is appropriate to ensure a smooth transition of OVEC's operations into PJM, but have not yet determined how much more time will be required. Because the final date for full integration is not yet known, the Parties request that FERC change the effective date of the Revised Tariff Sheets from March 1, 2018 to "12/31/9998", to reflect that the effective date has not yet been decided. The Parties will apprise the Commission of the actual effective date when it becomes certain, and will submit new versions of the Revised Tariff Sheets for acceptance by the Commission that reflect that date. This notice supersedes the Parties' request that the Commission grant the effective date requested in the February 26th Motion.
