Correction to eTariff Metadata - Revisions to PJM Operating Agreement, Schedule 12
and RRA, Schedule 17, Docket No. ER24-1469-000*

Dear Secretary Reese:

Pursuant to section 205 of the Federal Power Act,¹ and part 35 of the Federal Energy Regulatory Commission (“Commission”) regulations,² PJM Interconnection, L.L.C. (“PJM”)³ submits for filing a correction to certain metadata of proposed revisions to the Amended and Restated Operating Agreement of PJM Interconnection, L.L.C. (“Operating Agreement”), Schedule 12, and Reliability Assurance Agreement among Load Serving Entities in the PJM Region (“RAA”), Schedule 17 that was previously filed in Docket No. ER24-1469-000.⁴

On March 13, 2024, PJM Interconnection, L.L.C. (“PJM”) submitted with the Federal Energy Regulatory Commission (“Commission”), via eTariff, proposed revisions to the Amended and Restated Operating Agreement of PJM Interconnection, L.L.C. (“Operating Agreement”), Schedule 12, and Reliability Assurance Agreement among Load Serving Entities in the PJM

Region (“RAA”), Schedule 17, to update these lists to include new members, remove withdrawn members, reflect the signatories to the RAA, and reflect Member corporate name changes for the fourth quarter of 2023.⁵

After the filing was submitted, a typographical error was noted in the eTariff metadata of eTariff record number 278, version 58.0.0, priority order 500 of RAA, Schedule 17 – Parties to the Reliability Assurance Agreement’s effective date. The effective date was inadvertently inputted as 12/1/2023 instead of 12/31/2023. PJM submits this filing to correct its administrative eTariff metadata error. This correction to the metadata does not otherwise change the previously filed proposed revisions to the Operating Agreement, Schedule 12 or RAA, Schedule 17.
