PJM Interconnection, L.L.C.

On July 26, 2023, PJM Interconnection, L.L.C. submitted proposed revisions to the PJM Open Access Transmission Tariff (Tariff) and the Amended and Restated Operating Agreement of PJM (Operating Agreement).¹ PJM explains that the proposed revisions expand the Tariff and Operating Agreement provisions from PJM's *Hybrids Phase I* filing to a broader set of mixed technology facilities. PJM also explains that this proposal clarifies uplift rules to reflect the inverter-based hybrids and standalone storage available capability utilizing back-cast and state of charge data, consistent with the existing uplift rules for wind resources. PJM requests a November 1, 2023 effective date for all aspects of the filing, with the exception of those provisions related to uplift, for which PJM is requesting a "12/31/9998" effective date. Pursuant to authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, the tariff revisions are accepted for filing, as requested.²

The filing was publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission's regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed document(s); nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such action is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against the applicant(s).

This order constitutes final agency action. Requests for rehearing by the
